STANDARD FEE ATTENDED SERVICE [45/60 mins]

Fee includes a cremation service with mourners present at the crematorium held in **peak hours** (typically considered to be weekdays from 10am - 4.15pm).

Fee includes a cremation service with mourners present at the crematorium held in **off peak hours** (typically considered to be on a weekday before 10am), for which a reduced fee is charged.
